AMENDMENT intended to be proposed by Mr. CRAPO (for himself, Mr. WYDEN, Mr. RISCH, and Ms. BALDWIN) to the amendment (No. 2137) proposed by Ms. SINEMA (for herself, Mr. PORTMAN, Mr. MANCHIN, Mr. CASSIDY, Mrs. SHAHEEN, Ms. COLLINS, Mr. TESTER, Ms. MURKOWSKI, Mr. WARNER, and Mr. ROMNEY)

Viz:

- 1 In section 41202(b) of division D, strike paragraph
- 2 (2) and insert the following:
- 3 (2) ELECTION; SUBMISSION OF RESULTS.—Sec-
- 4 tion 102(b)(1) of the Secure Rural Schools and
- 5 Community Self-Determination Act of 2000 (16
- 6 U.S.C. 7112(b)(1)) is amended—

1 (A) in subparagraph (A), by striking “and  
2 August 1” and inserting “and September 30”;  
3 and

4 (B) by adding at the end the following:

5 “(E) ELECTION FOR FISCAL YEAR 2021.—  
6 Notwithstanding subparagraph (A), for fiscal  
7 year 2021, the election described in that sub-  
8 paragraph shall be made at the discretion of  
9 each affected county by September 30, 2021 (or  
10 as soon thereafter as the Secretary concerned  
11 determines is practicable), in accordance with  
12 paragraph (2), and transmitted to the Secretary  
13 concerned by the Governor of each eligible  
14 State.”.

15 (3) DURATION OF ELECTION.—Section  
16 102(b)(2)(A) of the Secure Rural Schools and Com-  
17 munity Self-Determination Act of 2000 (16 U.S.C.  
18 7112(b)(2)(A)) is amended, in the first sentence, by  
19 striking “to receive a share of the 25-percent pay-  
20 ment or 50-percent payment, as applicable,”.

21 (4) EXPENDITURE RULES FOR ELIGIBLE COUN-  
22 TIES.—Section 102(d)(3) of the Secure Rural  
23 Schools and Community Self-Determination Act of  
24 2000 (16 U.S.C. 7112(d)(3)) is amended by adding  
25 at the end the following:

1                   “(E) ELECTION FOR FISCAL YEAR 2021.—  
2           Notwithstanding subparagraph (A), for fiscal  
3           year 2021, the Governor of each eligible State  
4           shall notify the Secretary concerned of an elec-  
5           tion by an eligible county under this subsection  
6           not later than September 30, 2021 (or as soon  
7           thereafter as the Secretary concerned deter-  
8           mines is practicable).”.

9           (5) DISTRIBUTION OF PAYMENTS TO ELIGIBLE  
10          COUNTIES.—Section 103(d)(2) of the Secure Rural  
11          Schools and Community Self-Determination Act of  
12          2000 (16 U.S.C. 7113(d)(2)) is amended by striking  
13          “2020” and inserting “2023”.
