- 5 (a) ESTABLISHMENT.—Public Law 88-657 (16
- 6 U.S.C. 532 et seq.) (commonly known as the "Forest
- 7 Roads and Trails Act") is amended by adding at the end
- 8 the following:

1	"SEC. 8. FOREST SERVICE LEGACY ROAD AND TRAIL REME-
2	DIATION PROGRAM.
3	"(a) Establishment.—The Secretary shall estab-
4	lish the Forest Service Legacy Road and Trail Remedi-
5	ation Program (referred to in this section as the 'Pro-
6	gram').
7	"(b) Activities.—In carrying out the Program, the
8	Secretary shall, taking into account foreseeable changes
9	in weather and hydrology—
10	"(1) restore passages for fish and other aquatic
11	species by—
12	"(A) improving, repairing, or replacing cul-
13	verts and other infrastructure; and
14	"(B) removing barriers, as the Secretary
15	determines appropriate, from the passages;
16	"(2) prepare previously closed National Forest
17	System roads for long-term storage, in accordance
18	with subsections (c)(1) and (d), in a manner that—
19	"(A) prevents motor vehicle use, as appro-
20	priate to conform to route designations;
21	"(B) prevents the roads from damaging
22	adjacent resources, including aquatic and wild-
23	life resources;
24	"(C) reduces or eliminates the need for
25	road maintenance; and
26	"(D) preserves the roads for future use;

1	"(3) decommission previously closed National
2	Forest System roads and trails in accordance with
3	subsections (c)(1) and (d);
4	"(4) relocate National Forest System roads and
5	trails—
6	"(A) to increase resilience to extreme

9	"(B) to respond to changing resource con-
10	ditions and public input;
11	"(5) convert National Forest System roads to
12	National Forest System trails, while allowing for
13	continued use for motorized and nonmotorized recre-
14	ation, to the extent the use is compatible with the
15	management status of the road or trail;
16	"(6) decommission temporary roads—

4	"(ii) that have not been fully decommis-
5	sioned; and
6	"(7) carry out projects on National Forest Sys-
7	tem roads, trails, and bridges to improve resilience
8	to extreme weather events, flooding, or other natural
9	disasters.
10	"(c) Project Selection.—
11	"(1) Project eligibility.—
12	"(A) In GENERAL.—The Secretary may
13	only fund under the Program a project de-
14	scribed in paragraph (2) or (3) of subsection
15	(b) if the Secretary previously and separately—
16	"(i) solicited public comment for
17	changing the management status of the
18	applicable National Forest System road or
19	trail—
20	"(I) to close the road or trail to
21	access; and
22	"(II) to minimize impacts to nat-
23	ural resources; and
24	"(ii) has closed the road or trail to ac-
25	cess as described in clause (i)(I).

1	"(B) REQUIREMENT.—Each project car-
2	ried out under the Program shall be on a Na-
3	tional Forest System road or trail, except with
4	respect to a project carried out on a watershed
5	for which the Secretary has entered into a coop-
6	erative agreement under section 323 of the De-
7	partment of the Interior and Related Agencies
8	Appropriations Act, 1999 (16 U.S.C. 1011a).
9	"(2) Annual selection of projects for
10	FUNDING.—The Secretary shall—
11	"(A) establish a process for annually se-
12	lecting projects for funding under the Program,
13	consistent with the requirements of this section;
14	"(B) solicit and consider public input re-
15	gionally in the ranking of projects for funding
16	under the Program;
17	"(C) give priority for funding under the
18	Program to projects that would—
19	"(i) protect or improve water quality
20	in public drinking water source areas;
21	"(ii) restore the habitat of a threat-
22	ened, endangered, or sensitive fish or wild-
23	life species; or

1	"(iii) maintain future access to the
2	adjacent area for the public, contractors,
3	permittees, or firefighters; and
4	"(D) publish on the website of the Forest
5	Service—
6	"(i) the selection process established
7	under subparagraph (Λ) ; and
8	"(ii) a list that includes a description
9	and the proposed outcome of each project
10	funded under the Program in each fiscal
11	year.
12	"(d) Implementation.—In implementing the Pro-
13	gram, the Secretary shall ensure that—
14	"(1) the system of roads and trails on the ap-
15	plicable unit of the National Forest System—
16	"(A) is adequate to meet any increasing
17	demands for timber, recreation, and other uses;
18	"(B) provides for intensive use, protection,
19	development, and management of the land
20	under principles of multiple use and sustained
21	yield of products and services;
22	"(C) does not damage, degrade, or impair
23	adjacent resources, including aquatic and wild-
24	life resources, to the extent practicable;

1	"(D) reflects long-term funding expecta-
2	tions; and
3	"(E) is adequate for supporting emergency
4	operations, such as evacuation routes during
5	wildfires, floods, and other natural disasters
6	and
7	"(2) all projects funded under the Program are
8	consistent with any applicable forest plan or trave
9	management plan.
10	"(e) SAVINGS CLAUSE.—A decision to fund a project
11	under the Program shall not affect any determination
12	made previously or to be made in the future by the Sec
13	retary with regard to road or trail closures.".
14	(b) AUTHORIZATION OF APPROPRIATIONS.—There is
15	authorized to be appropriated to the Secretary of Agri
16	culture to carry out section 8 of Public Law 88–657 (com
17	monly known as the "Forest Roads and Trails Act"
18	\$250,000,000 for the period of fiscal years 2022 through
19	2026.
