Methane Partners Campaign Fellowship

The Methane Partners Campaign (MPC) Fellowship is a paid fellow program designed to immerse its participants in the environmental advocacy field, specifically within the context of methane regulation. Assignments vary and are designed to both support the campaign with its mission to support campaign partner advocacy on methane regulation, as well as assist the fellow with their professional development. This non-exempt position allows interaction with all of the campaign's partners, providing a wide breadth of experiences. As an integral part of the campaign team, fellows will experience how public support is generated for action on methane regulation, as well as better understand the confluence of state-based and federal organizing. While MPC is based in Washington, D.C., we are currently working remotely.

Who We Are

The Methane Partners Campaign (MPC) was formed in 2015 as a collaborative coalition campaign to push the Obama administration to address methane pollution from the oil and gas industry. Founded by leaders in the environmental, public health, and labor spaces, over the past seven years we've grown into a diverse coalition led by national and state advocacy organizations, with over 125 coalition partners joining the fight.

Our priority goals for 2022 build on our success over the last five years defending the previous methane standards ("2016 Rules") and pivot to pushing for the enactment of even stronger methane regulations under the Biden administration, while also maintaining pressure on corporate actors through our industry accountability campaign.

- 1. Build political support for the Biden administration to go beyond reinstating the 2016 Rules.
- 2. Advocate for proposed EPA rules for new and existing sources projected to cut nationwide oil and gas methane pollution by 65% by 2025.
- 3. Win any ongoing litigation over the merits of the 2016 Rules (EPA and BLM) and the illegality of the 2020 rollbacks.

Primary Duties and Responsibilities

The Fellowship will be focused heavily, but not exclusively, on the following work flows:

- Interacting with campaign partners on a regular and ongoing basis to complete projects
- Assisting the team with organizational duties including, but not limited to, data and record management
- Assisting with campaign-wide metrics and reporting
- Creating, editing, and distributing a variety of documents and reports for internal and external use
- Assisting various campaign partners during surge moments, including but not limited to reporting, writing, research, and data entry
- Attending internal meetings around MPC and campaign-wide methane advocacy efforts
- Providing logistics and meeting support as needed
- Completing other duties and tasks as they arise / are assigned
