

## Position – Climate & Financial Regulation Policy Director Public Citizen's Climate Program

Public Citizen is a national, non-partisan, public interest group with more than 500,000 members and supporters. We hold the government and corporations accountable with campaigns and advocacy before Congress, administrative agencies, and the courts, on issues including money in politics, open government, financial regulation, energy and the climate crisis, fair trade, consumer protection, access to justice, workplace safety, drug and medical device safety, and more. We are the reason why there are air bags and backup cameras in cars and there were no red M&Ms for a decade. And much more.

Public Citizen's Climate Program is advocating for financial policy that advances the transition away from fossil fuels and promotes rather than impedes racial, economic, and intergenerational justice. We've played major roles on both climate and financial regulation, from passing the Dodd-Frank Wall Street Reform and Consumer Protection Act to conceiving and co-leading the development of the Vision for Equitable Climate Action, the only comprehensive climate policy platform among U.S. NGOs that centers equity and has the ambition to align the U.S. with a 1.5°C warming pathway.

**GENERAL DESCRIPTION:** We are running dynamic policy and corporate campaigns to cut financing and insurance for fossil fuels. This position combines management, policy expertise, and advocacy with strategic savvy. The right candidate will be a sharp strategic thinker, creative tactician, thoughtful and empowering supervisor, and skilled organizer, both digitally and offline.

#### RESPONSIBILITIES

- Policy development and advocacy: Identify emerging issues and opportunities. With the Climate Program director, develop policy proposals and advocacy strategies. Write white papers, reports, fact sheets, letters, testimony, and comments on proposed rules. Advocate and testify before Congress and administrative agencies. Plan and execute legislative and administrative advocacy campaigns. Collaborate with the Program director and other staff in developing and executing plans to engage activists in influencing policy.
- **Supervision:** Supervise a team of policy advocates and other staff as needed, as well as interns and volunteers.
- **Outreach and collaboration:** Represent Public Citizen in public forums. Develop high-level contacts and relationships in key organizations and institutions and collaborate with groups and coalitions engaged in this work. Participate actively in coalitions and, where appropriate, lead them.
- **Media and public education:** Develop and maintain media relationships and respond to press inquiries, serving as a spokesperson. Help develop research and media strategies in coordination with other staff. Write editorial board memoranda, press releases, op-eds, letters to the editor,

and blog posts.

- **Organization building:** Assist the director in writing grant proposals and reports.
- **Making things happen:** Above all, make a difference. Write the papers, recruit the partners, hold the meetings, work with the coalitions, lobby the regulators and members of Congress, organize the event. Do what's needed to win.
- Other duties as necessary.

### QUALIFICATIONS

- J.D. or other relevant advanced degree, knowledge of financial services regulation and seven or more years of relevant policy or advocacy experience, and two or more years of management experience.
- Strong commitment to ending the climate crisis, particularly by cutting off the money pipeline from Wall Street to fossil fuel companies, and passion for advancing racial and economic justice.
- Outstanding analytical thinking, judgment, and oral and written communication skills.
- Independence and strong impulses toward self-starting and self-finishing.
- Ability and eagerness to learn new, complex material quickly.
- Ability to balance multiple projects and priorities, as well as execute planned strategies while reacting to new developments. Ability to work in a fast-paced environment, respond to short-term deadlines, balance multiple responsibilities, and maintain accuracy and attention to detail.
- Collaborative spirit, high energy, and enthusiasm.
- Willingness to work long hours when necessary.

#### SALARY AND BENEFITS

Salary range: \$95,365 to \$123,359, based on experience and qualifications
