## **GENERAL MESSAGING**

### What's At Stake

**This is a battle for the soul of our nation.** The stakes of the Supreme Court vacancy are enormously high for the future of civil and human rights. The Court plays a critical role as the backstop when other institutions fail to protect people's civil and human rights.

- The issue most immediately under threat is access to healthcare, especially for women. During his political campaign, Trump bragged that he would only appoint judges who would "automatically" overturn Roe v. Wade and undermine the Affordable Care Act, which would have a devastating impact on those with pre-existing conditions, people of color, women, people with disabilities, and millions of others for decades to come. Access to health care is a civil and human rights issue of profound importance.
- Our rights and freedoms on the line. Whether you care about access to healthcare, voting rights, immigrant justice, LGBTQ rights, or criminal justice reform, the fate of them all hang in the balance.
- We still have work to do to ensure everyone's civil and human rights are recognized and protected. But we cannot let President Trump rewrite the Constitution and roll back all the progress we've made. This is not a hypothetical threat; it is real.

The broad civil and human rights coalition is united in its commitment to fight for our rights. We will mobilize to protect the integrity of the Supreme Court from extremists who would turn back the clock.

- Senators must hear our voices and be an independent check on this president.
- There is simply too much at stake literally the protection of our civil and human rights to rush through such a consequential confirmation.



#### **Toxic Process**

Brett Kavanaugh, like Neil Gorsuch, was plucked from a toxic short list of individuals who met Trump's extreme agenda. Earning a spot on this list of anti-civil and human rights all-stars required satisfying the ultraconservative Heritage Foundation and Federalist Society. As a nominee on this list, Brett Kavanaugh passed Trump's ideological litmus test as a person who, if confirmed, would take away women's control over their own bodies and sabotage accessible health coverage for millions of people.

• Recent Supreme Court decisions are a devastating reminder of what one Trump justice has already brought us. Collective bargaining rights, women's access to health care, fair elections, and access to voting rights have all been diminished in the past Supreme Court term.



## **KAVANAUGH TALKING POINTS**

#### Kavanaugh currently serves as a judge on the U.S. Court of Appeals for the D.C. Circuit.

- Since Kavanaugh's name was on Donald Trump's short list of potential nominees approved by the Heritage Foundation and Federalist Society, we know he satisfied Trump's litmus test as a person who, if confirmed, would "automatically" <u>overturn</u> *Roe v. Wade* and who would work against accessible and affordable health care. We should believe Trump when he says these basic civil and human rights will be undermined and gutted by his pick, including Kavanaugh.
- In the now-famous "Jane Doe" case, Kavanaugh <u>tried</u> to block an undocumented minor in government custody from exercising her constitutionally protected right to an abortion. Over Kavanaugh's dissent, the D.C. Circuit <u>allowed</u> the young woman to seek the care she needed.
- In a case challenging the Affordable Care Act, Kavanaugh <u>wrote</u> a dissenting opinion that would have kept alive a frivolous attack on the health care of millions of Americans.
- Kavanaugh believes the president should be above the law. He has <u>said</u> the president should have "absolute discretion" to determine whether and when to appoint a special counsel like Robert Mueller. And he <u>said</u> that special counsels should be "removable in the same manner as other highlevel executive branch officials" - in other words, at the president's prerogative. Kavanaugh has also <u>said</u> that a sitting president should not be able to be criminally indicted, no matter what evidence of wrongdoing is uncovered. He would not serve as a much-needed check on the executive branch.
- Kavanaugh is a narrow-minded ideologue who would favor the wealthy and powerful over protecting the civil and human rights of all people. Throughout his tenure on the bench, he has consistently ruled against workers, consumers, and the environment.

Additional points:

- He <u>believes</u> the Consumer Financial Protection Bureau, which was created to protect consumers from unscrupulous financial institutions, is unconstitutional.
- He <u>argued</u> that the FCC's net neutrality rule benefitting millions was unconstitutional.
- Kavanaugh has repeatedly ruled against protections for <u>clean air</u> and <u>clean water</u>.
- In one case he <u>tried</u> to reverse an EPA penalty against a company that improperly shipped a corrosive chemical that caused "significant risks to public health."



- He has <u>fought</u> for cable companies and the auto industry, against consumers.
- Kavanaugh has a poor record on antitrust issues: He <u>stood</u> with multi-billion dollar insurance companies that were merging to eliminate consumer choice.
- He has consistently ruled against workers <u>fighting discrimination</u> and <u>mistreatment</u> on the job.
- He is so extreme that he has the highest number of dissents per year of any judge on the D.C. Circuit.
