Dear Minority Leader Schumer, Vice Chairman Leahy, and Ranking Member Udall,

On behalf of our millions of supporters and members nationally, we thank you for your leadership in keeping FY19 appropriations legislation, including the Interior and Environment Appropriations bill (H.R. 6147), free of new anti-environmental policy riders.

With the end of the fiscal year quickly approaching, your leadership becomes even more critical as the threat from harmful riders shifts to the conference process. As you know, the House funding bills contain many unacceptable riders. We urge you to continue emphasizing to House leadership and conferees that bills carrying these provisions will not pass the Senate.

A <u>recent Gallup poll</u> revealed that "sixty-two (62) percent of Americans currently say the government is doing too little to protect the environment — the highest in 12 years." The poll further defines how President Trump's anti-environmental agenda is contrary to U.S. public opinion. Voters "support more, rather than less, government action to protect the environment."

The poll results are not surprising because people across our country share a moral obligation to protect our children's health and our public lands, air, water, oceans, and wildlife for future generations. The federal budget sets the priorities for our government to uphold this commitment — even one harmful policy rider can break this promise.

Our families need Congressional leaders to abandon the poison pill policies that continue to corrupt the appropriations process. We support and thank you for your leadership in standing with these families and passing final funding bills that are free of anti-environmental riders.
